Dear Speaker Pelosi and Leaders McConnell, McCarthy, and Schumer:

As Congress takes action to advance legislation responding to the COVID-19 pandemic, the Oral Health Progress and Equity Network (OPEN), as represented by the almost 200 undersigned organizations, **strongly urges you to advance policies that support the important role of oral health in addressing this crisis. Specifically, we ask that you include policies in the next COVID-19 relief package that:**

- 1. Stabilize state budgets to protect access to essential oral health care by increasing the Federal Medical Assistance Percentage (FMAP) by at least 12 percent and further increasing the FMAP for Medicaid dental services by five percent; and
- 2. Provide immediate support to state health departments and oral health programs by establishing an oral health infrastructure fund to respond to crisis-related oral health needs.

This current public health crisis is straining our nation's oral health care system, leaving millions of Americans without access to essential health care necessary to combat COVID-19. When basic oral health care is out of reach, many people have no choice but to turn to expensive emergency room settings for dental relief, further straining hospital capacity. In addition, poor oral health can have a direct, adverse impact on management of diabetes, heart disease, and obesity, increasing chances of complications from COVID-19. Unfortunately, the populations who face the most significant barriers to oral health are also those most disproportionately affected by COVID-19 and its economic impacts.

Without additional support for the oral health care system and state infrastructure, our nation's oral health needs cannot be met as the pandemic and its economic consequences wear on. This will exacerbate long-standing disparities in oral health and overall well-being. As states face continued budget shortfalls, adult dental coverage in Medicaid will also be at significant risk. Millions of Americans could find themselves without coverage and unable to afford care. Simultaneously, dental providers, including those in private practice and safety net clinics like community health centers, are experiencing significant reductions in revenue that could put them out of business.¹ With a projected 66 percent decline in overall dental spending for 2020,² the oral health care system needs additional support to offer urgent, on-going care and address the backlog of oral health needs in the wake of COVID-19.

To address these issues:

We support the request of the National Governors Association³ to increase the FMAP funding for Medicaid in order to stabilize state budgets and protect access to essential oral health care. Increasing the FMAP by at least 12 percent will help stabilize state budgets and allow states to provide health coverage for the 72 million individuals currently covered by Medicaid. It will also allow state Medicaid programs to respond to increasing demand in the months ahead due to historic levels of unemployment.

We recommend an enhanced FMAP for Medicaid dental services in order to address the strategic role of dental services at this time. An increase of five percent for dental services will help to ensure that care remains available, which is particularly important to the health of those with underlying chronic conditions. It would also support oral health professionals to take a more active role in COVID-19 response.

We recommend the establishment of a \$75 million fund to be directed by the Secretary of the Department of Health and Human Services that supports state oral health programs in addressing their populations' immediate, crisis-related oral health needs. The allocation of federal funding directly to state oral health departments will allow states to respond flexibly to the individual needs of their constituents within state-determined scope and capacity. This may include sourcing and coordinating personal protective equipment, providing direct safety-net care to uninsured individuals, collecting relevant data, investing in telehealth technology, and/or expanding COVID-19 testing capabilities.

Our collective response to this pandemic will only be effective if it addresses all aspects of health and well-being. Investing in our nation's health and economic prosperity requires that health and dental care remain available and supported by a strong oral health infrastructure.
